# Process from 9th January 2023

Make your dealership aware that you are an NFU member and are eligible for the discount. Dealership will complete relevant consortium paperwork with you to send to NFU for approval of the discount.

## **Terms and Conditions**

- This programme is available to NFU Farmer and Grower, NFU Partner & NFU Retired members, Employment service members and Countryside members (only specific models) which meet the following criteria:
  - Be an NFU Farmer and Grower member, Partner (provided they are linked to an F&G record), retired Employment Service or Countryside member.
  - ii. Have maintained 12 months of continuous membership at point of request, and
  - iii. Have made a minimum of 12 months subscription payment with a Direct Debit instruction set up for the current membership year if paying by Direct Debit or have made a minimum of 12 months subscription payment and in addition, have paid in full for the current membership year at the point of request, subject to NFU discretion, if a cash payer.
  - iv. In addition, NFU Partner memberships must be linked to a valid NFU Farmer & Grower membership to be
- 2. This programme is not available to any other NFU membership categories or any member that does not meet the eligibility criteria, as set out in Point 1.
- 3. Eligible members are allowed a maximum of 1 Lexus vehicle discount per membership year (a membership year constitutes 1st November 31st October). Requests for a second Lexus vehicle discount will be considered by Lexus on case-by-case basis.
- A member with associated businesses in selling motor vehicles is not applicable or entitled to receive vehicle discount through the Consortium Programme.
- 5. A discount is likely to be declined if:
  - i. The name and address on the approval form does not match details held by the NFU.
  - ii. The consortium form is not completed in full before being submitted to the NFU.
- 6. The NFU discount will be deducted by the supplying dealer from the basic price (before VAT, delivery and On the Road charges).
- 7. During the period of this Agreement, the price payable for each vehicle shall be the then current List Price, at the time of the relevant order, less the discount as set out in the Supply Terms of this Agreement, plus manufacturer's delivery, VAT, Road Fund Licence and First Registration Fee.
- 8. Vehicle must be purchased for personal or business use, linked to the eligible member and not for re-sale purpose.
- 9. No vehicles may be disposed of before 12 months from registration or supply date under (whichever is the earlier) this Agreement without prior written permission from Lexus.
- 10. Any non-factory fitted options and onward delivery charges (over and above the manufacturer's delivery charge) must be agreed separately with supplying centre.
- 11. Lexus reserves the right to add and delete models within the Lexus range.
- 12. The NFU or Lexus may change the terms and conditions, including the availability of the deal at any time and without notice.
